ARTICLE I. NAME

The name of this corporation is:

J & J BOOKS, INC.

ARTICLE II. NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation is to sell books to the public, and any aspect and phase of any and every lawful business, including, but not limited to, the following activities:
