The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

# ARTICLE I NAME AND PRINCIPAL OFFICE

The name of this corporation is Central Plumbing of NW FL, Inc., and its principal office is located at 1998 Coral Street, Navarre, Florida 32566, and its mailing address is 1998 Coral Street, Navarre, Florida 32566.

### ARTICLE II DURATION

This corporation shall exist perpetually.

# ARTICLE III PURPOSE
