ARTICLE I

The name of the corporation is IT'S A LONG RIDE, INC., and its mailing address and principal place of business is 5801 North Congress Avenue, Boca Raton, Florida 33487.

The corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.


#### ARTICLE X

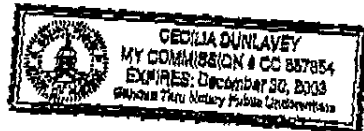


