ARTICLES OF INCORPORATION
OF

ARTICLE I. NAME AND ADDRESS. The name of this corporation shall be Tom Vick Farms, Inc., and its principal office address is: 33011 SW 210 Avenue, Homestead, FL 33030. Its mailing address is: P.O. Box 901461, Homestead, FL 33090-1461.

ARTICLE II. DURATION. This corporation is to exist perpetually.
