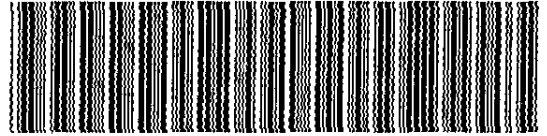



**ARTICLE I - NAME**

The name of this corporation is **JAM-R-EE ENTERTAINMENT INT'L, INC.**


**ARTICLE IX - INDEMNIFICATION**




