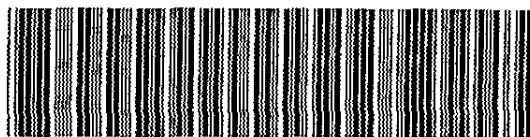

ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME

The name of this Corporation is XAVIER RIVERA, INC.

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing
on June 16, 2003.


