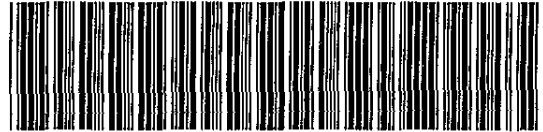

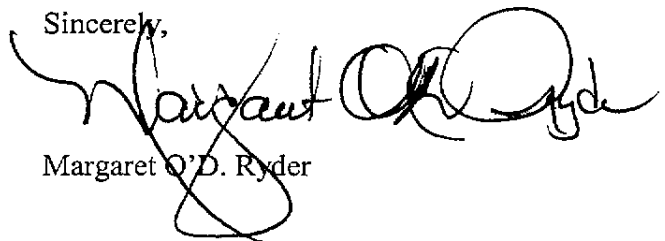

**ARTICLES OF INCORPORATION  
OF  
ADVENIR INC.**

**ARTICLE I - NAME AND BUSINESS ADDRESS**

The name of this Corporation is Advenir, Inc. a Florida corporation. Its principal office address and business mailing address is 4780 NW 9th Street, Plantation, Florida 33317.

**ARTICLE II - DURATION**

The Corporation shall have a perpetual existence.

**ARTICLE III - PURPOSE**

The purpose for which the Corporation is organized is to engage in any and all businesses and activities permitted by the laws of the State of Florida. The Corporation shall have all of the powers vested in a limited liability company organized and existing by virtue of such laws.

**ARTICLE IV - CAPITAL STOCK**

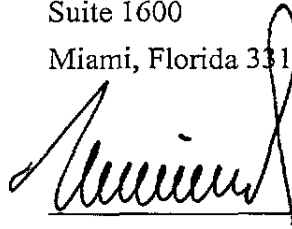

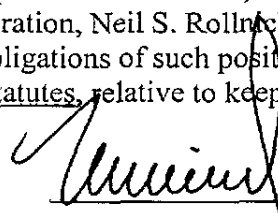
