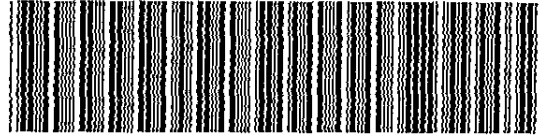

**ARTICLES OF INCORPORATION  
OF  
R. KRUEGER CONSTRUCTION, INC.**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

**ARTICLE I: NAME**

The name of the corporation shall be R. KRUEGER CONSTRUCTION, INC.

**ARTICLE II: PRINCIPAL OFFICE**

The principal place of business of the corporation shall be 618 Fayette Drive South, Safety Harbor, Florida 34695. However, the corporation shall have power to establish branch offices and other places of business at such other places within or without the State of Florida as may be determined and deemed expedient by the Directors.

The mailing address of the corporation shall be P.O. Box 1072, Safety Harbor, Florida 34695.

### **ARTICLE III: PURPOSE**

The corporation is organized to operate for any legal or lawful purpose or purposes.

### **ARTICLE IV: SHARES**

The capital stock of the corporation shall be divided into shares of \$1.00 par value, with 7500 shares of common stock authorized, and each share shall entitle the holder thereof to vote at any meetings of the shareholders and to share in the net assets of the corporation upon dissolution. All or any part of the capital stock may be paid for in cash, with property, or in labor or services, at a valuation fixed by the incorporators or by the Board of Directors, at a meeting called for such purpose.

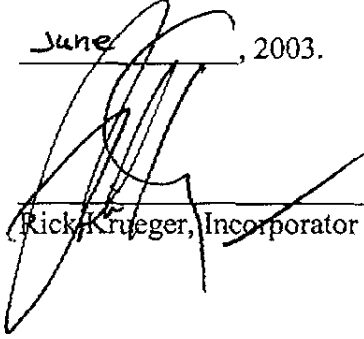

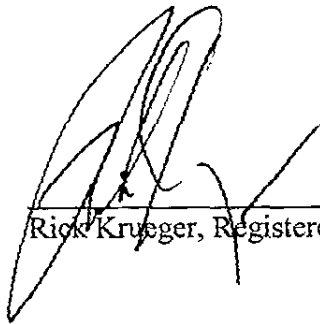
