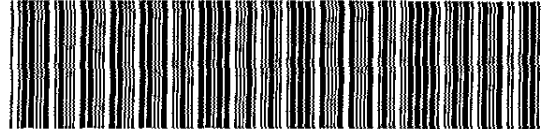

shareholders in lieu of directors.


