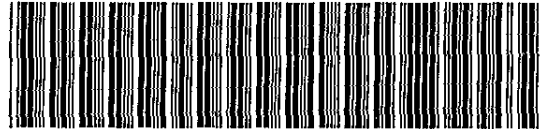

ARTICLES OF INCORPORATION
DE
MILLENNIUM CIGAR CO.

PURSUANT TO SECTION 607.0902, FLORIDA STATUTES, THESE ARTICLES OF INCORPORATION PROVIDE THAT.

ARTICLE ONE

THE NAME OF CORPORATION IS MILLENNIUM CIGAR CO. (THE "CORPORATION")

ARTICLE TWO

THIS CORPORATION SHALL HAVE PERPETUAL EXISTENCE, AND ITS CORPORATE EXISTENCE SHALL COMMENCE AT THE TIME OF THE FILING OF THE ARTICLE OF INCORPORATION BY THE DEPARTMENT OF STATE.

ARTICLE THREE

THE CORPORATION SHALL ENGAGE IN ANY ACTIVITY OF BUSINESS PERMITTED UNDER THE LAWS OF THE UNITED STATE AND THE STATE OF FLORIDA.

ARTICLE FIVE

THE STREET OF THE INITIAL REGISTERED OFFICE OF THE CORPORATION IN THE STATE OF FLORIDA IS. 13876 SW 56TH STREET SUITE 252 MIAMI, FLORIDA 33175 AND THE NAME OF THE REGISTERED AGENT OF THIS CORPORATION AT THAT ADDRESS IS ARMANDO FUMERO, THE PRINCIPAL OFFICE AND/OR MAILING ADDRESS WILL BE THE SAME AS THE REGISTERED OFFICE.

ARTICLE SIX

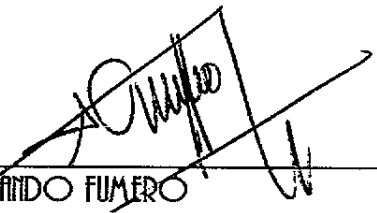
