

The undersigned, for the purpose of forming a corporation hereby adopts the following Articles of Incorporation.

**ARTICLE I
(NAME)**

The name of the corporation is "SUPREMA MUSIC, INC.

**ARTICLE II
(Duration)**

The duration of this corporation is perpetual.

**ARTICLE III
(Purpose)**

The general purpose for which this corporation is organized is to engage in the operation of ANY AND ALL FORMS UNLIMITED, INVENTED OR TO BE INVENTED, EXISTING OR YET TO EXIST, OF ENTERTAINMENT, LIVE PERFORMANCES, EXECUTIONS, DIRECTION, PRODUCTION, REPRODUCTION, PRINTING, MANUFACTURING, DISTRIBUTION, SONG WRITING, LYRIC WRITING, RECORDING CONTRACTS, PROGRAMMING, PROMOTIONS AND MUSICAL PRODUCTIONS IN ANY AND ALL FORMS, METHODS AND CAPACITIES AS AGENCY, AGENT, REPRESENTATIVE, MANAGEMENT, BOOKING AGENCY, PROMOTION AND ADVERTISING AGENCY, PUBLISHING HOUSE AND OR COMPANY, IMPRESARIO, PROMOTER, ENTREPRENEUR IN ANY AND ALL FIELDS AND OR AREAS IN PART OR IN WHOLE COVERED AND OR SPECIALIZED IN TELEVISION, FILM, PHOTOGRAPHY, MOVIES, RADIO, MUSIC, THEATER, CONCERTS, FESTIVALS, EVENTS, PLAYS, ARTS, SPORTS, BOOKS, NEWSPAPERS, MAGAZINES, ARTISTS, ACTS, WRITERS, COMPOSERS, PLAYWRIGHTS, SCREEN WRITERS, LIBRETTIST, CONDUCTORS, BROADCASTERS, LIVE AND OR RECORDED.

ARTICLE IV

(Initial registered office, registered agent, principal office and mailing address)






