Name

The corporation shall indemnify any Officer or Director, or any former officer or Director, to the full extent permitted by law.

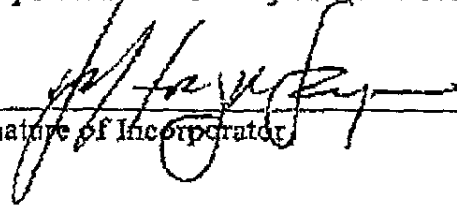

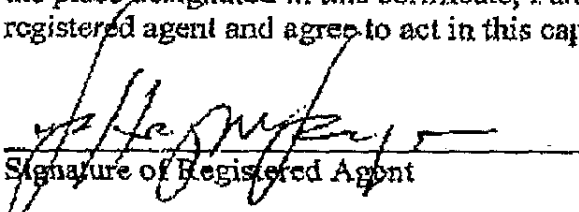
