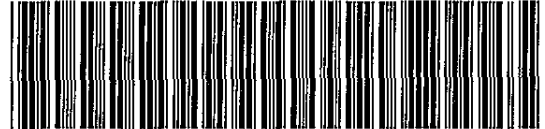

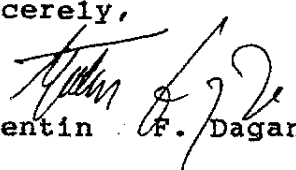

The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I-NAME

The name of the corporation is: TRISTAR MARKETING AND STAFFING, INC.

ARTICLE III-NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation is marketing and staffing services and other activities permitted under the laws of the United States and the State of Florida.

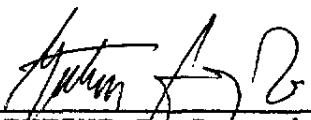
