We enclose an application for Corporation Reinstatement of 150 EAST, INC., which was dissolved in 2004 for failure to file an Annual Report.

We request waiver of the Reinstatement Fee because we believe we did not receive the Annual Report Notices in 2004. The basis of our belief is that we have no record of having received such notices, and we believe that they may not have been delivered to us by the Post Office.
