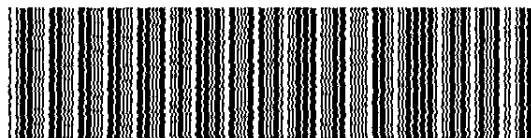

ARTICLES OF INCORPORATION
OF
UNDERWRITER'S HOLDING JOINT VENTURE, INC.

ARTICLE I

The name of this corporation is UNDERWRITER'S HOLDING JOINT VENTURE, INC.

ARTICLE II

This Corporation shall have perpetual existence, unless sooner dissolved according to law.

ARTICLE III

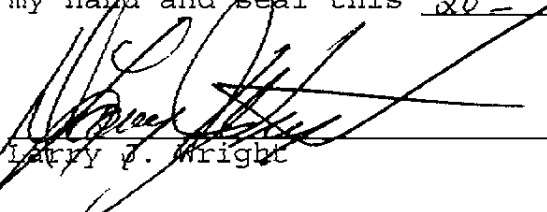

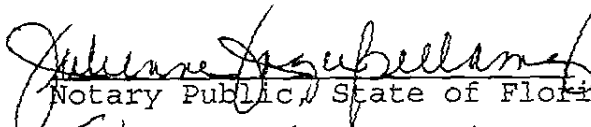
