The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

Article I

The name of the corporation is: **Carolyn M. Canada, P.A.** The principal place of business of this corporation shall be 4442 Chuluota Road, Orlando, FL 32820.

Article II

This corporation may engage or transact in the sale of real estate as permitted under the laws of the United States, the State of Florida, or any other State, or country.

Article III

The maximum number of shares that this corporation is authorized to have outstanding at any one time is 8,000 shares of common stock having a par value of \$1.00 per share.

Article IV

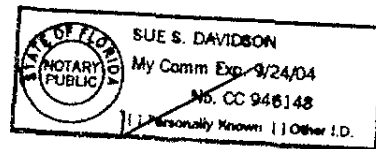
