

**ARTICLES OF INCORPORATION
OF
STRZ AGENCY INT'L, INC.**

ARTICLE I - NAME

The name of this corporation is **STRZ AGENCY INT'L, INC.**

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE III - PURPOSE


ARTICLE IX - INDEMNIFICATION




