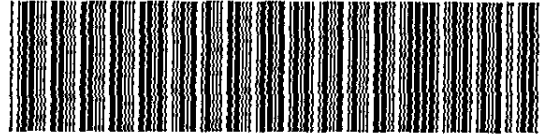



ARTICLES OF INCORPORATION OF

M-AND-MS LAND SERVICES, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation shall be: M-AND- MS LAND SERVICES , INC.


