ARTICLES OF INCORPORATION

I, the undersigned, being of full age and duly licensed under Chapter 475, Florida Statutes, do hereby subscribe for the purposes of forming and organizing a corporation under the provisions of Chapter 621, Florida Statutes, and hereby adopt and declare the following Articles of Incorporation covering the existence and organization of this corporation:

ARTICLE I

The name of the corporation shall be D.E. Keller Associates, P.A.

ARTICLE II

This corporation may engage in every phase and aspect of real estate brokerage and sales, including rentals, property management, consulting and marketing. In addition the corporation may invest the funds of the corporation in real estate, mortgages or any other type of investment, and own real and personal property necessary for the rendering of its services.

ARTICLE III
