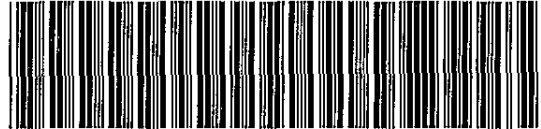

# ARTICLES OF INCORPORATION






