ARTICLE I - NAME

The name of the Corporation is:

Pinnacle Holding Company of Manatee County, P.A., a Florida corporation

ARTICLE II - PRINCIPAL OFFICE

The street address of this corporation's initial principal office is 4110 Manatee Avenue West, Bradenton, Florida 34205. The mailing address of the corporation is 7252 Manatee Avenue, Bradenton, Florida 34209.

ARTICLE III - DURATION

This corporation shall have perpetual existence, commencing on July 1, 2003.



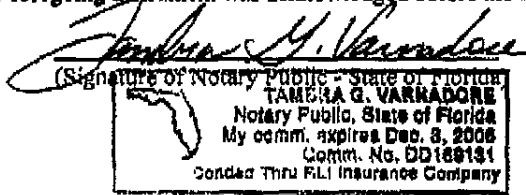


