

ARTICLES OF INCORPORATION OF

ARTICLE I-NAME

The name of this Corporation is SUN COAST POWER INVESTMENT, INC.

ARTICLE II-DURATION

This Corporation shall have a perpetual existence commencing on the Date of Filing.
