**ARTICLES OF INCORPORATION
OF

ARTICLE I-NAME

The name of this Corporation is **SUN COAST POWER INVESTMENT, INC.**

ARTICLE II-DURATION

This Corporation shall have a perpetual existence commencing on the Date of Filing.

ARTICLE III-PURPOSE

This Corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE IV-CAPITAL STOCK
