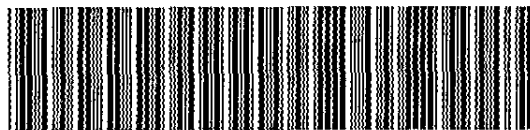

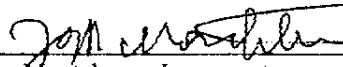
ARTICLE VIII-EFFECTIVE DATE
