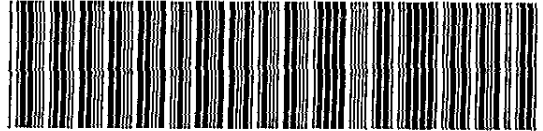

ARTICLES OF INCORPORATION

ARTICLE I
NAME

The name of the Corporation is: AGORA'S INTERIORS, INC., a domestic corporation which is not a member of any affiliated group.

ARTICLE II
PRINCIPAL OFFICE

The principal place of business of this corporation shall be: 10040 Cross Creek Blvd., Tampa, Florida 33647.

The principal mailing address of this corporation shall be: 10040 Cross Creek, Blvd., Tampa, Florida 33647.

ARTICLE III
PURPOSE

The general purposes for which the Corporation is organized are:

1. To engage in the business of interior design services, offered with home furnishings and gifts both for the residential and commercial markets; and
2. To transact any other lawful business for which corporations may be incorporated under the Florida General Corporation Act or engage in any other trade or business which can, in the opinion of the Board of Directors of the Corporation, be advantageously carried on in connection with or auxiliary to the foregoing business.
3. To do such other things as are incidental to the foregoing or necessary in order to accomplish the foregoing.
