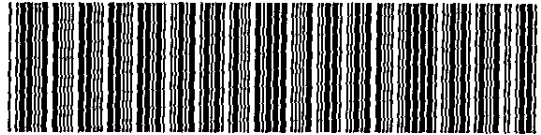

**ARTICLE I - NAME**

The name of this corporation is Klip-It Services, Inc.

**ARTICLE II - DURATION**

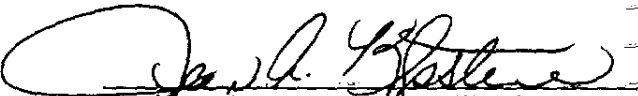
