ARTICLES OF INCORPORATION For PROFESSIONAL CORPORATION (F.S. 607.0202 and CHAPTER 621)

The undersigned natural person, competent and licensed to practice <u>as a Real Estate</u> <u>Salesperson</u> in the State of Florida, acting hereby as Incorporator for the purpose of forming a Professional Association Corporation for profit under the provisions of Sections 607, Florida General Corporation Act, and Section 621, Florida Professional Corporation Act, of the Florida Statutes, does hereby adopt the following Articles of Incorporation.
