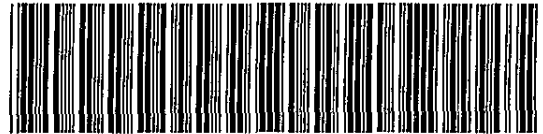

# **ARTICLES OF INCORPORATION OF**

**D & S GLASS, INC.**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

## **ARTICLE 1. NAME**

The name of the corporation shall be: D & S GLASS, INC.

## **ARTICLE II. NATURE OF BUSINESS**


