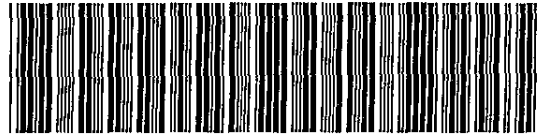

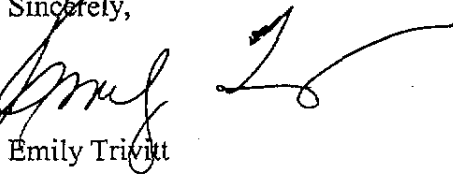

Article V. Initial Registered Agent and Street Address

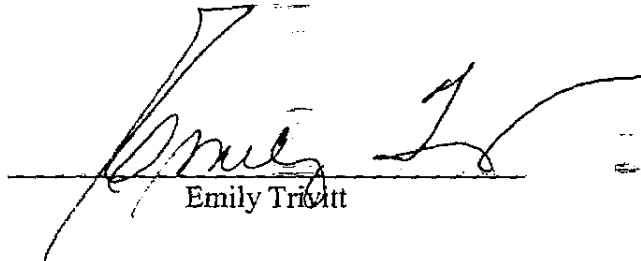

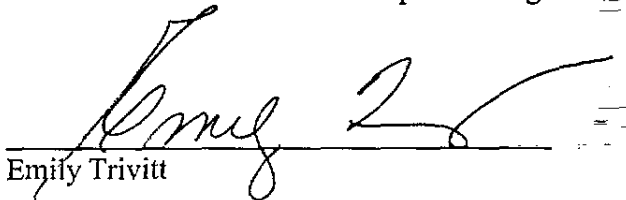
