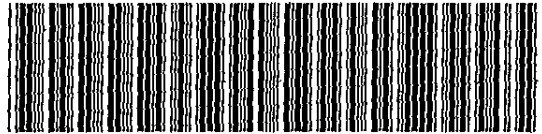



ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation act, adopts the following articles of incorporation for such a corporation.

ARTICLE I - NAME

The name of the corporation is Confer's Superior Image, Inc.

ARTICLE II - PURPOSE AND NATURE OF BUSINESS

The corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida. The nature of the business of the corporation and the objectives and purposes to be transacted shall be:

- (a) That the corporation shall be formed for the purposes of providing home improvement and/or home remodeling services throughout the State of Florida to the general public;
- (b) To borrow, execute notes, mortgages and deeds, or other evidence of indebtedness, and to secure the same by pledge or otherwise, of any and all of the products or assets of the corporation for any purpose necessary or expedient in the operation of said businesses;
- (c) To do all things that may become necessary, expedient in the proper conduct of the business functions of the corporation;
- (d) To associate or create any other lawful business or businesses or to create subsidiaries for the operation of the same within the laws of the State of Florida and the United States of America.

ARTICLE III - PRINCIPAL OFFICE

The address of the initial principal office is 8701 Exposition Drive, Tampa, Florida 33626.

ARTICLE IV - CAPITAL STOCK

The maximum number of shares this corporation is authorized to issue is one thousand (1000) shares.

ARTICLE V - REGISTERED AGENT

The registered agent for this corporation is Ronald E. Perez, Jr., Esquire and the address of the registered office of this corporation is 2124 West Kennedy Boulevard, Suite A, Tampa, Florida 33606.

ARTICLE VI - INCORPORATOR

The name and address of the incorporator of this corporation is: Karis Confer 8701 Exposition Drive, Tampa, Florida 33626.


ARTICLE VII - BOARD OF DIRECTORS AND OFFICERS
