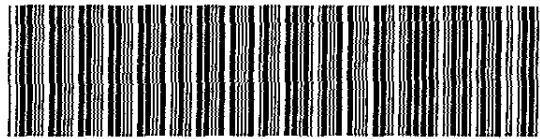

The undersigned incorporator of a Florida corporation for profit, hereby sets forth and shows:

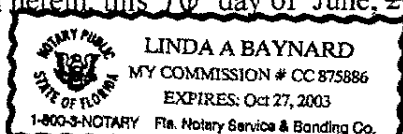
1. The name of this corporation is LAKESIDE LANDINGS CAMPGROUND, INC..
