OF



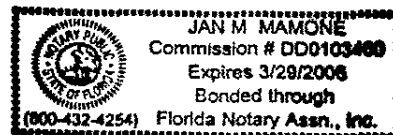


