**FINAL ORDER**

This matter is before the Department upon a petition by Car Sales of the Palm Beaches, Inc. to voluntarily have its motor vehicle dealer license revoked. Accordingly it is **FOUND** and **ORDERED** as follows:

1. Petitioner is the state agency charged with regulating the business of buying, selling, or dealing in motor vehicles or offering or displaying motor vehicles for sale, pursuant to section 20.24 and chapter 320, Florida Statutes, and Rule 15C-7, Florida Administrative Code.
2. Respondent is a licensed motor vehicle dealer in the State of Florida, having been issued license number VI-1008019, based upon the application identifying Zareh Arzuman as President. The address of record is 3720 NE 40<sup>th</sup> Place, Ocala, Florida 34479.
3. Respondent executed and filed an Agreement for Voluntary Revocation of License dated August 6, 2016, wherein it agrees to the revocation of its motor vehicle dealer license.
4. The Agreement for Voluntary Revocation of License filed by Respondent is accepted and adopted by reference herein and made a part hereof.
5. Respondent, has acknowledged in the Agreement for Voluntary Revocation of License that it wishes to cease doing business as a motor vehicle dealer, that there are or currently may be pending outstanding sales transactions where payoffs of trade-in vehicles or

lien applications have not been made or for which application for title and registration have not been made, and that an Administrative Complaint could have been issued, which could have resulted in the revocation of its license.

Therefore, it is **ORDERED AND ADJUDGED** that motor vehicle dealer license number VI-1008019 is hereby **REVOKED** effective immediately.

Respondent is directed to surrender its license and any temporary tags in its possession to the Division of Motor Vehicles and to cease and desist doing business immediately.

Licensee understands that they would be entitled to a hearing on the alleged violations contained in an Administrative Complaint prior to the Department's issuance of a Final Order revoking licensee's CAR DEALERSHIP license,

Licensee further waives their right to seek judicial review of or to otherwise challenge or contest the Final Order revoking their license.
