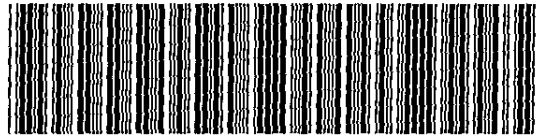

**ARTICLES OF INCORPORATION
OF
MEDIA IMPRESSIONS, INC.**

ARTICLE I - NAME AND ADDRESS

The name of this corporation shall be MEDIA IMPRESSIONS, INC., a Florida Corporation. The principal office of the corporation is 2430 Periwinkle Way, Suite B, Sanibel Island, Florida 33957; the mailing address of the corporation is P.O. Box 716, Sanibel, Florida 33957.

ARTICLE II - TERM OF EXISTENCE

This corporation is to have perpetual existence.

ARTICLE III - PURPOSE

The general nature of the business to be transacted by this corporation shall be as follows:

- A. To organize and operate a media placement services company in the State of Florida.
- B. To transact any and all lawful business in the State of Florida pursuant to Florida Statutes, Chapter 607.

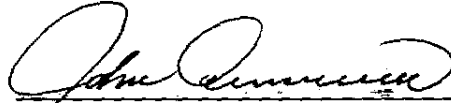

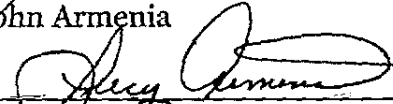

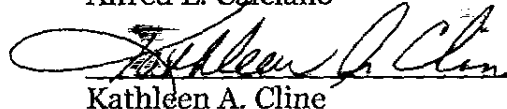
