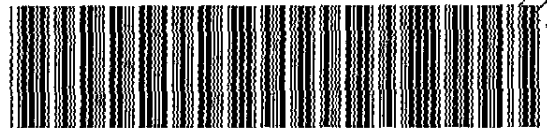

ARTICLE I - NAME

The name of this corporation is N S Business, Inc. and the address is 1498 Transmitter Road, Panama City, Florida 32401.

ARTICLE II - TERM OF EXISTENCE

This existence of this corporation shall exist perpetually.

ARTICLE III - NATURE OF BUSINESS

This corporation may engage or transact in any or all activities or businesses permitted in the laws of the United States of America and the State of Florida.
