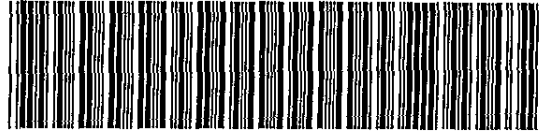

The capital stock of this Corporation shall be 100 shares of common stock having a par value of \$1.00 per share.






