**ARTICLES OF INCORPORATION
OF

The undersigned, acting as incorporator of the captioned corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I
Corporate Name and Principal Office

The name of this corporation is Tampa Bay Clipper, Inc., and its principal office and mailing address is 4505 Onorio Street, New Port Richey, Florida 34653.

ARTICLE II
Commencement of Corporate Existence

The corporation shall come into existence on June 24, 2003.

General Nature of Business

The corporation may transact any lawful business for which corporations may be incorporated under Florida law.


