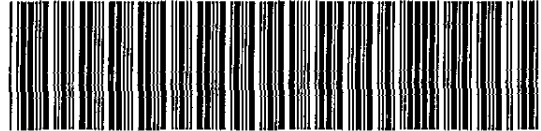


ARTICLE VIII


