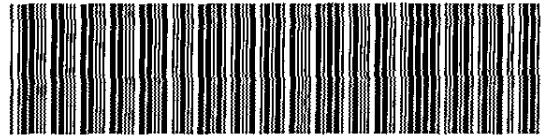

of
