The undersigned hereby makes and subscribes to these Articles of Incorporation intending to form a corporation under the provisions of the Florida Statutes.

ARTICLE I - NAME

The name of this corporation is PARK AVE BBQ & GRILLE OF DELRAY BEACH, INC.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business is 969 Southeast 5th Avenue, Delray Beach, Florida 33483-5108 and the mailing address of the Corporation is 4135 Burns Road, Palm Beach Gardens, Florida 33410-4605.

ARTICLE III - PURPOSE

The Corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.
