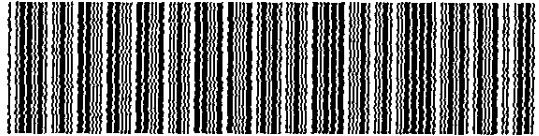

ARTICLES OF INCORPORATION

MEL CURTIS TOWING, INC.

The undersigned Incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I ~ NAME

The name of the corporation shall be MEL CURTIS TOWING, INC.

ARTICLE II ~ PRINCIPAL OFFICE

The principal place of business and of the corporation shall be 1305 W. King Street, Cocoa, Florida 32922; the mailing address of the business and of the corporation shall be P.O. Box 1186, Cape Canaveral, Florida 32920.
