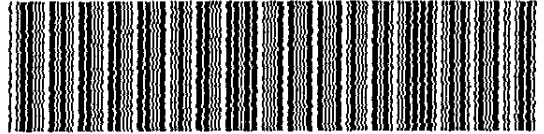



**ARTICLES (AMENDED) OF INCORPORATION OF
ORAGE PUBLISHING INC.**

In compliance with the requirements of Florida Statutes § 607, et. seq., the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is ORAGE PUBLISHING INC..

ARTICLE II

The existence of the Corporation shall begin on July 1, 2003.

ARTICLE III

The street address of the principal office of the Corporation is ORAGE PUBLISHING INC., 1460 Wren Court, Punta Gorda, FL 33950.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 1000, par value \$1.00 per share, all of which shall be Common Shares.
