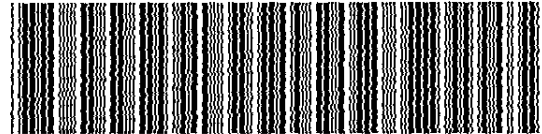

SECRETARY OF STATE

In compliance with the requirements of Chapter 607 of the Florida Statutes (the "Florida Business Corporation Act"), the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a for profit business corporation.

**ARTICLE I**

**NAME**

The name of the corporation (hereinafter called the "Corporation") is Legal Alibi, Inc.

**ARTICLE II**

**ADDRESS**

The mailing address of the Corporation is 3225 Aviation Avenue, Suite 600, Miami, Florida 33133-4741.

**ARTICLE III**

**PURPOSE**

The Corporation is being organized for any legal purpose.

**ARTICLE IV**

**CAPITAL STOCK**

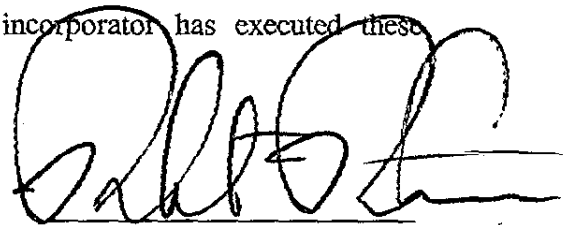

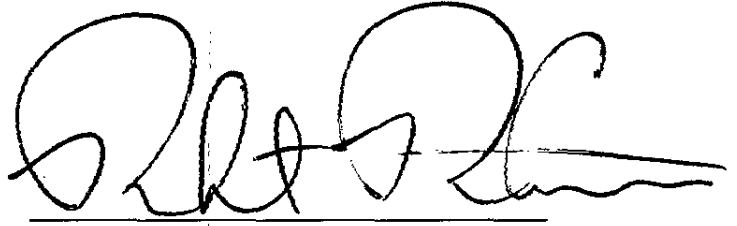
