The undersigned, acting as sole incorporator, adopts these Articles of Incorporation and forms a profit corporation (the "Corporation") under the Florida Business Corporation Act ("Act"), as follows:

**I.
Name**

The name of the Corporation is Hinderstein Investments, Inc.

**II.
Term of Existence**

The date when corporate existence will commence is June 23, 2003 in accordance with Section 607.0203(1) of the Act.

**III.
Principal Office**

The principal office and mailing address of the Corporation is Post Office Box 1576, Mercer Island, Washington 98040.

**IV.
Capital Stock**

The Corporation is authorized to issue 10,000 shares of \$1.00 par value common stock, which will be designated Common Stock.


