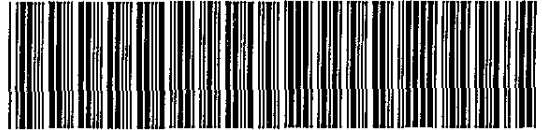



ARTICLE I.

NAME

The name of this corporation is O'CONNOR INDUSTRIES, INC.

ARTICLE II.

PRINCIPAL OFFICE

The principal office of this corporation and the mailing address of this corporation is 4500 140th Avenue North, Suite 202, Clearwater, Florida 33762.

ARTICLE III.

DURATION: EFFECTIVE DATE

This corporation shall exist perpetually, commencing as of June 25, 2003.

ARTICLE IV.


