

OF



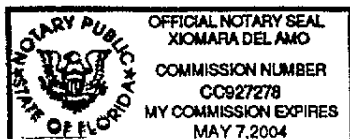
