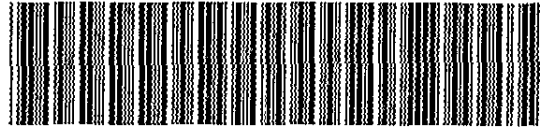

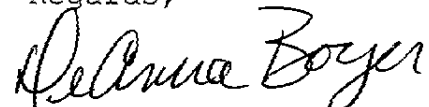

The undersigned incorporator, for the purpose of forming a for profit corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation

ARTICLE I. NAME.

The name of the corporation shall be DeAnna Boyer, Inc.

ARTICLE II. PRINCIPAL OFFICE & MAILING ADDRESS.

The principal place of business of this corporation shall be: 1 NW Hwy 19, Crystal River, Florida 34428. The mailing address of this corporation shall be: 1 NW Hwy 19, Crystal River, Florida 34428.

ARTICLE III. PURPOSE

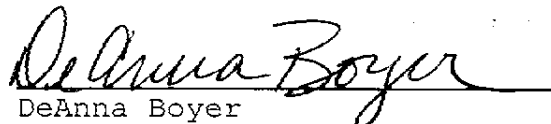
