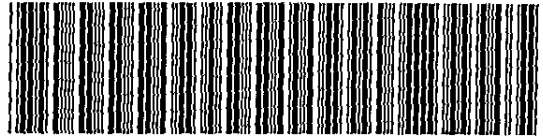

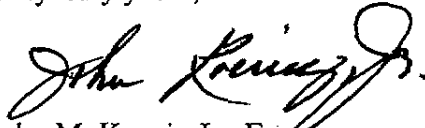

## **ARTICLE I- NAME AND ADDRESS**

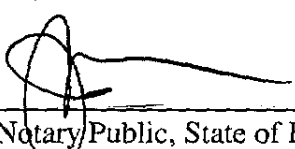

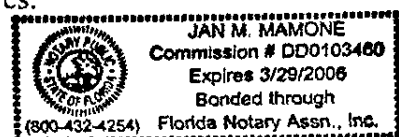

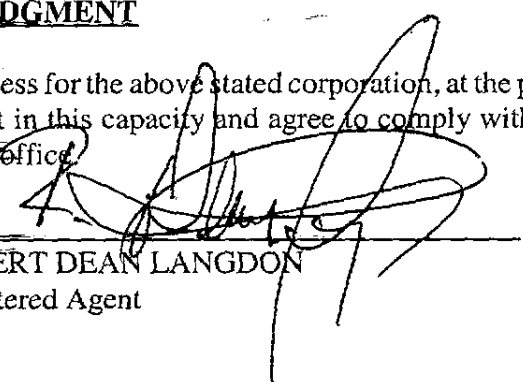
