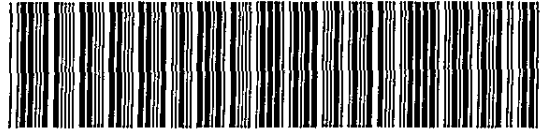

1. **Name.** The name of the corporation is: TITLE RESOURCES OF GAINESVILLE, INC.
