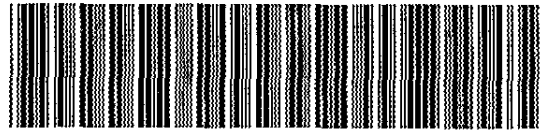

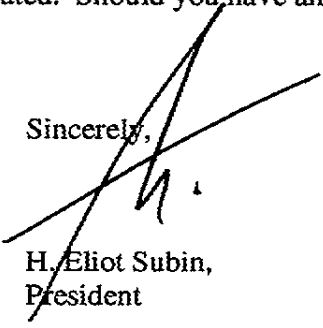

Pursuant to the provisions of Section 607.1006 of the Florida Statutes, SunBridge Group, Inc., a Florida corporation, does hereby amend its Articles of Incorporation.

1. The name of the corporation whose Articles of Incorporation are being amended by these Articles of Amendment is SunBridge Group, Inc., a Florida corporation.

2. Article I of the Articles of Incorporation of SunBridge Group, Inc., a Florida corporation, is hereby deleted in its entirety, and the following Article I is hereby inserted in its place:

ARTICLE I. NAME

The name of the corporation shall be: JLT/BBQ, Inc.

3. The amendment to the Articles of Incorporation of SunBridge Group, Inc., a Florida corporation, set forth in paragraph 2 above was duly adopted by the Board of Directors of the corporation on March 18, 2004 and by the shareholders of the corporation on March 18, 2004.

4. The only voting group entitled to vote on the amendment to the Articles of Incorporation of SunBridge Group, Inc., a Florida corporation, set forth in paragraph 2 above was the holders of shares of Common Stock of the corporation.
